1. Meeting Notes (April): Approved - No opposed.

2. Treasurer's Report (April): Approved – No opposed.

- 4. Banquet: Decision made and confirmed November 12<sup>th</sup> for banquet date. Save the date to membership. We need to make decisions on prizes. Next steps explore approach to menu with Historic Concorde Exchange – "Valentino." The venue is located in St Paul. Facility has hotel space that can be rent for the event. Committee needs to meet again to firm up other details.
- 5. Education Committee: Haven't been able to meet since the clinic at Fortuna Farm. Betsy is going to try to contact Patrice Urban regarding a clinic on course design for members. It was mentioned that Heather P. had asked the Urban's and they are on board with doing the clinic the first week of Mason

City – Summerfest show. MHJA will sponsor and provide refreshments. We can hang signage at the show the Urbans just want to know what it is. Betsy Kieffer will call Dan and will get details. Zandra Powers test is now a written test, no riding. Having the test be written may present opportunities for more juniors and amateurs to participate. Discussed holding a raffle to encourage people to take the test. Horsemanship study guide is on the USHJA website. Comprehensive resource and useful resources.

6. **Membership & Website**: Due to scams, Board decided it's best to remove personal phone numbers for the website and refer inquiries to the general email address until we can get a secure site. Heather will figure out cost to update website. Horseman's directory needs to be assembled for publication. Show specs changes include YE award participation will dropped from 2 shows to 1 show to qualify and modify children/adult amateur can run concurrently if more than 6 rides but pinned separately. Specs need to be updated and posted on website.

27 new competing members joined since last meeting. Total competing members are now at 158. It was suggested that a message get posted to the website before Mason City reminding people to renew membership. Heather F will send a list of members to Betsy K.

Jeni watched an online demo of "Orgpro" software which part of the Horse Shows online program. General thoughts were that it is one of the hardest programs to work with. Jeni looked at another software for point management. Today, we get printed results from horse show offices. Goal is to get data to automatically upload to a software program to streamline process.

Alyssa will create a posted reminding people of the May 26<sup>th</sup> due date for entries for Midstates Shows.

- 7. Succession Planning: Searching for a President for next year. We need to start recruiting process for a leader for the BOD. Looking for leader who will bring good energy and enthusiasm to the organization as well as motivate members to be active in the organization. Norine will talk with trainers for potential candidate ideas. BOD is amateur heavy need a balance with professionals.
- 8. **Horse Show Approval:** Received application from Tracy Grandstand for two Stonegate Horse shows. One show July 8th through 10th for jumpers; and another from July 15<sup>th</sup> through 17<sup>th</sup> for hunters. Need to separate shows to manage the allowable number of people and horse on the property at one time. No specific request of MHJA.
